I do hereby affirm the permit will not be used or represented in any way as an endorsement by the City or department or officer thereof; that during the period specified in the permit, if there is any change in fact, policy or method that would alter the information given in the application, I will notify the City Clerk in writing thereof within 48 hours after that change; that at no time during the period of Solicitation or Peddling will I or my agents Solicit or Peddle at any business or residence within the City where there is clearly and visibly posted any sign requesting "No Solicitation" or "No Trespassing" or words of similar meaning; that at no time during the period of Solicitation or Peddling will I or my agents Solicit or Peddle at any residence or business within the City the property owner or resident of which has signed the "No Visit" list; that I will carry on my person a copy of the Solicitation or Peddling permit issued by the City; and that at no time during the period of validity of the permit will I Solicit or Peddle without carrying a state or federal government-issued identification card, and that I am legally eligible, by age, to obtain such an identification card.
