

NOTICE TO TRAFFIC VIOLATORS

Your traffic summons requires you to appear in person before the Municipal Court of Parkville, Missouri, on the date written at the top left of the ticket, UNLESS you wish to plead guilty in writing and pay your fine by mail or at the Traffic Violation Bureau before your court date.

Only those violations listed on this notice may be paid in advance or by mail. **YOU MUST APPEAR IN COURT IF YOU WERE INVOLVED IN AN ACCIDENT.** If your violation is listed and you wish to plead guilty without coming to court, follow these steps:

- 1.) Sign your name to the "Appearance Plea of Guilty and Waiver of Trial" on the back of your ticket.
- 2.) Obtain a money order or cash (**NO PERSONAL CHECKS ACCEPTED**) in the appropriate amount payable to: Parkville Municipal Court.
- 3.) If you choose to pay by mail, the fine must be postmarked five (5) days prior to the court date and a self addressed stamped envelope must be included. If you choose to pay in person, present the traffic summons and payment to the Court Clerk's office. Mail to or make payments at:

WARNING: If you fail to appear in court or your payment has not been received by your scheduled court appearance, the court will send notice to suspend your drivers license, issue a warrant for your arrest, and will consider implementing contempt proceedings.

If your driver's license was taken as bond, you may pick it up in person at the Court Clerk's office.

Fines and cost payable thru the TVB are listed on the reverse side.

Only the following violations listed on the schedule may be paid in advance or by mail with a money order or cash. VISA/MC payments in person only.
