First, you can assist the city in being aware of Federal and State funding and program opportunities and how to access them. The state is a vital resource for ongoing state and federal program dollars, as well as the one-time infusion of federal funding from programs such as ARPA, IIJA, IRA. Second, the legislature every year is developing policies and funding that directly impact city operations and our communities. Working with us on such legislation is critical to us and we can be a valuable resource on the impact of proposed legislation. Following are a few specific issues or opportunities we are particularly interested in working together with you:

Reduction in these sources of funding will force the city to make reductions in services and investments at the very time we need to increase those services and investments because of the rapid growth we are experiencing.
