**PARKVILLE MUNICIPAL CODE CHAPTER 362
OPERATION REGULATIONS FOR
GOLF CARTS & LOW SPEED VEHICLES (LSV'S)**

- A. All drivers must be 16 years and older and licensed to operate a motor vehicle as provided by Missouri Traffic Regulations and carry a valid driver's license as provided by Missouri Traffic Regulations.
- B. All drivers of golf carts/ LSV's shall abide by all traffic regulations applicable to vehicular traffic when using the authorized streets and parking areas of the City of Parkville.
- C. Golf carts/ LSV's shall not be operated on any sidewalks or trails at any time.
- D. The authorized driver of a golf cart or LSV operating the vehicle on a street (as defined herein) can cross an excluded street where the speed limit is greater than 35 miles per hour, but otherwise may not operate a golf cart/ LSV on any such excluded street or road.
- E. Golf carts/ LSV's are prohibited from pulling trailers, boats, jet skis, other objects, people or animals on public streets and the right-of-way.
- F. Driver and passengers shall:
 - 1. Be limited to the seating capacity as designed by the manufacturer.
 - 2. Be seated at all times while the cart/ vehicle is in motion.
- G. Drivers shall maintain financial responsibility as required for other passenger vehicles as required by RSMO Chapter 303.
- H. Any person who violated the terms of this ordinance shall be penalized subject to the traffic regulations of RSMO Chapter 304, Section 304.029.
- I. The Riss Lake subdivision is surrounded by State highways, which do not allow golf carts. Riss Lake residents are not allowed to drive a golf cart outside of the subdivision because they are not allowed on state highways, sidewalks or trails.

I hereby acknowledge by my signature below that I have received, read and understand Section 362 Operation Regulations for Golf Carts & Low Speed Vehicles (LSV's), and that failure to abide by these rules and regulations may result in penalties, fines, suspensions, and other legal remedies as prescribed by the Parkville Municipal Code and other applicable County, State and Federal laws as may be applicable.
