2. Applications with substantial changes from the approved preliminary plan or plat shall be submitted and heard by the Board of Aldermen in accordance with the deadlines for preliminary applications; and substantial changes may require approval of an amended preliminary plan or plat.
3. Zoning map amendment, preliminary development, conditional use permit, and text amendment applications require a public hearing; this schedule has been determined to allow adequate time for filing a protest petition per RSMo 89.060.
4. City Staff will conduct the public notice requirements per Section 403.010.E. Notice will be published in the newspaper the prior Wednesday.
